First, I want to correct an error I made in my last report: the recipient of the 1992 SRCE Excellence in Teaching Award was not Lois Avery as I reported but SuzAnne C. Cole, who has taught at Houston Community College since 1981 both as a part-time and full-time instructor.

The Southwest Regional Conference on English in the Two-Year College (SRCE) continues to show growth and vigor in serving the some 1500 full-time teachers of English in the two-year colleges of its six-state region--Arkansas, Colorado, Louisiana, New Mexico, Oklahoma, and Texas. In February, the SRCE Executive Committee met in Austin, Texas, where the following highlights were reported:

Financially, SRCE is solvent with a balance of \$3167.69 in its treasury. In addition, SRCE has approximately 225 dues-paying members with the membership chairman reporting that membership dues continue to come in with each SRCE activity or publication. The Committee also approved raising the annual dues from \$6.00 to \$10.00. Significantly, the committee approved the NCTE proposal for restructuring the Two-Year College, College, and University section.

SRCE is looking forward to its 1993, October 21-23 convention in San Antonio with the host college Palo Alto College. In addition, the Conference has already been given a tentative schedule for its 1994 conference, which will be hosted by Laredo Junior College in Laredo, Texas, October 13-15, 1994.

SRCE continues to have outstanding Newsletters published at Westark (Arkansas) Community College under the stellar editorship of Mike Cooper. Finally, SRCE continues to have outstanding support from its CCCC Liaison, Dr. William E. Tanner of Texas Woman's University. The 1992-93 SRCE Executive Committee roster is attached.
